ASSIGNMENT OF WELLS, OIL AND GAS LEASEHOLD INTERESTS AND WATER LINES; AND BILL OF SALE

This Assignment of Wells, Oil and Gas Leasehold Interests and Water Lines; and Bill of Sale is dated and effective as of October 1, 2025 (the "Effective Date"), and is made by River Rock Energy Company, an Oklahoma corporation, 211 N. Robinson, Suite 200, Oklahoma City, Oklahoma 73102 ("Assignor") to SEK Energy Operating, LLC, a Kansas limited liability company, 149 Benedict Road, Benedict, Kansas 66714 ("Assignee").

RECITALS:

WHEREAS, pursuant to the terms of that certain Agreement dated effective October 1, 2025 (the "Agreement"), the assets described in the Exhibits attached hereto are being conveyed by Assignor to Assignee.

I. GRANTING PROVISIONS

Section 1.1 Conveyance of Leasehold Interests, Oil and Gas Wells, Saltwater Disposal Well, and Water Gathering Pipelines etc. For and in consideration of One Hundred Dollars (\$100.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does, subject to the terms and provisions of this Assignment, hereby assign and convey to Assignee, free and clear of all liens, claims, and encumbrances, the following:

A. All of Assignor's interest in and to the oil and gas leases described in Exhibit A attached hereto, together with the rights incident thereto and the personal property appurtenant thereto or used in connection therewith, and to the extent not specifically described in Exhibit A, all of Assignor's interest in and to any oil and gas leases upon which the wells described in Exhibit A attached hereto are located, together with rights and interests granted or transferred to Assignor or any of its predecessors-in-interest under any force pooling or unitization order covering the lands or units upon which such wells are located;

B. All of Assignor's interest in and to the wells described in Exhibit A attached hereto, together with all rights and equipment relating thereto, including but not limited to all leases, rights and interests acquired under force pooling or unitization orders, permits, licenses, pumping units, casing, rods, tubing, wellhead equipment, valves, telemetry

equipment, separators, heater treaters, oil and water tanks, meters, and flow lines, and

C. All of Assignor's interest in and to water gathering pipelines and any related easements or rights-of-way, described in Exhibit A attached hereto.

D. Any contracts and agreements, whether described on Exhibit A or not, that may be related to the Oil and Gas Assets to the extent necessary to enable the operation of such assets.

The property and assets described above are hereafter referred to as the Oil and Gas Assets.

II. GENERAL COVENANTS AND PROVISIONS

Section 2.1 – Counterpart Execution

This Assignment may be executed in any number of counterparts, and each counterpart hereof shall be deemed to be an original instrument, but all counterparts shall constitute but one Assignment.

Section 2.2 – No Waiver

No waiver of any of the provisions of this Assignment shall be deemed or constitute a waiver of any other provision of this Assignment, nor shall such waiver constitute a continuing waiver unless otherwise expressly provided.

Section 2.3 – Governing Law

THIS ASSIGNMENT AND THE LEGAL RELATIONS BETWEEN THE PARTIES SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF KANSAS, WITHOUT REGARD TO SUCH STATE'S CONFLICTS OF LAW PRINCIPLES OTHERWISE APPLICABLE TO SUCH DETERMINATIONS.

Section 2.4 – Agreement

This Assignment is subject to the terms of the Agreement.

Section 2.5 – Modifications Only in Writing

This Assignment may be amended or modified only by an agreement in writing executed by all of the parties hereto.

Section 2.6 – No Warranty

This assignment is made without warranty of title express or implied, but is made with the full rights of substitution and subrogation of Assignee, in and to all covenants and warranties of

others heretofore given or made with respect to the Oil and Gas Properties. All personal property and equipment are transferred in their current operating condition, and is sold "AS IS AND WHERE IS, WITH ALL FAULTS AND DEFECTS" and "WITHOUT WARRANTY OF ANY KIND WHETHER EXPRESS, IMPLIED OR STATUTORY," AND ASSIGNOR EXPRESSLY DISCLAIMS AND NEGATES: (a) any express or implied warranty of merchantability, and (b) any implied or express warranty of fitness for a particular purpose.

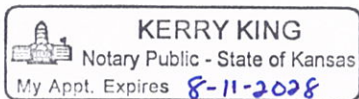

Water Gathering System Being Assigned

All of Assignor's interest in what is known as the "Hull Water Gathering System" located in Sections 25, 26, 34 and 35-27S-15E, and Sections 2 and 3-28S-15E, all in Wilson County, Kansas, which system is used to gather saltwater produced from the oil and gas wells covered by this Assignment, as well as other wells including the wells retained by Assignor in the foregoing sections, for delivery to the Hull 34-1 SWD located in Section 35. This conveyance includes all of Assignor's rights to any saltwater gathering lines in such sections, together with any easements or rights-of-way relating thereto, to the point of interconnection with Assignor's main gathering system located at a valve at Ness Road in the southwest corner of the Northwest Quarter of Section 36-27S-18E, Wilson County, Kansas. With respect to the wells retained by Assignor hereunder, Assignee will own the saltwater lines up to the valve between the poly saltwater line and the steel line located on the well pad. Assignor will own the steel lines up to the valve where such lines are connected to the poly water lines on the well pad.
