- acknowledges that Tradewater Well Services, LLC ("Tradewater") is plugging the Well to generate carbon benefits, and more specifically, carbon offset credits,
- affirms that the undersigned initially granted Tradewater access to the Property to assess the Well on July 15, 2025,
- grants Tradewater ongoing access through the completion of the plugging process, and for a period of at least eighteen (18) months after the completion of post-plugging monitoring, for the following Well-related activities: leak testing, measurement, plugging and decommissioning, and other post-plugging activities, including plug permanence checks, that may be necessary to generate carbon benefits, and
- affirms that, to the best of the undersigned's knowledge, the Well has not been previously plugged, and that neither Tradewater nor any other party has communicated specific current plans, or conveyed any financial commitments, to plug the Well for a purpose other than Tradewater's present intended purpose of plugging the Well to generate carbon benefits.
