- affirms that the undersigned initially granted Tradewater access to the Property to assess the Wells on July 16, 2025,
- grants Tradewater ongoing access through the completion of the plugging process, and for a period of at least eighteen (18) months after the completion of post-plugging monitoring, for the following Well-related activities: leak testing, measurement, plugging and decommissioning, and other post-plugging activities, including plug permanence checks, that may be necessary to generate carbon benefits, and
