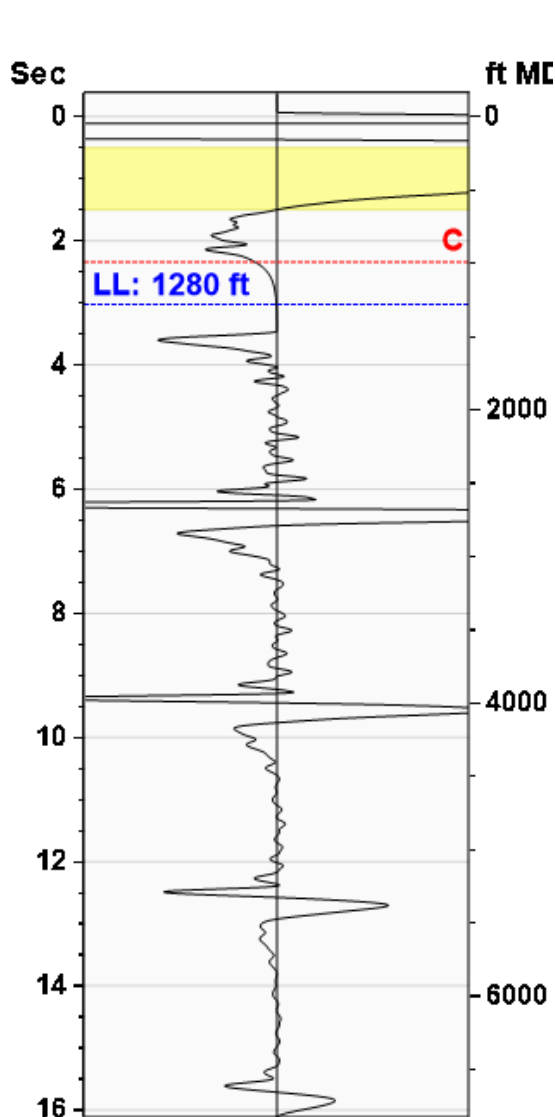

Liquid Level

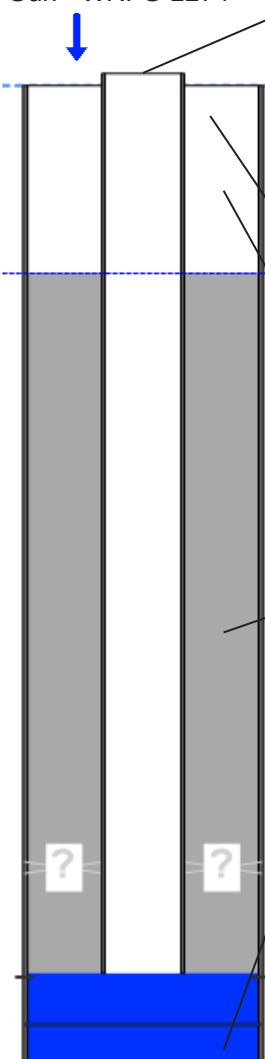

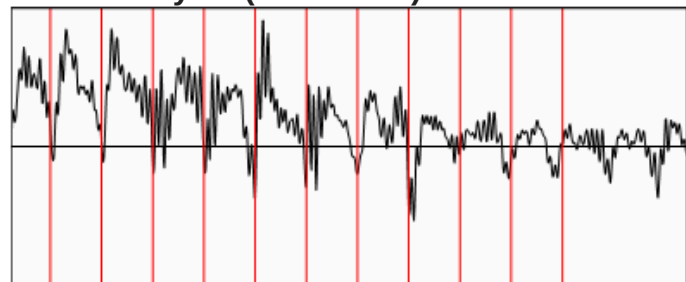

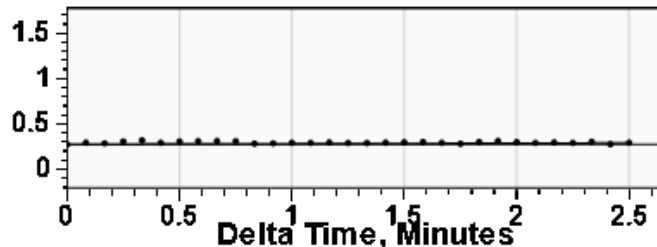
