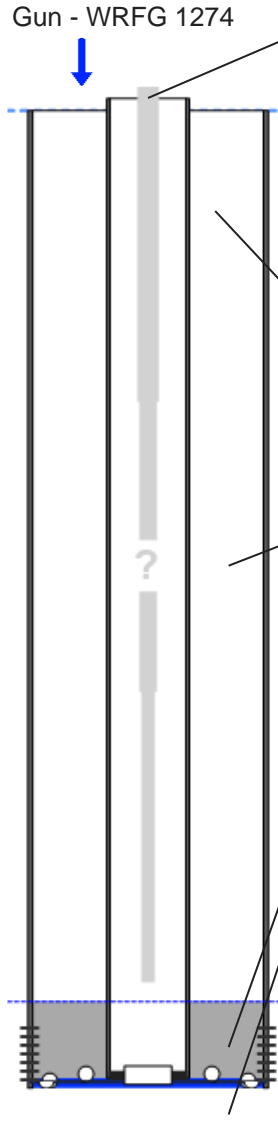
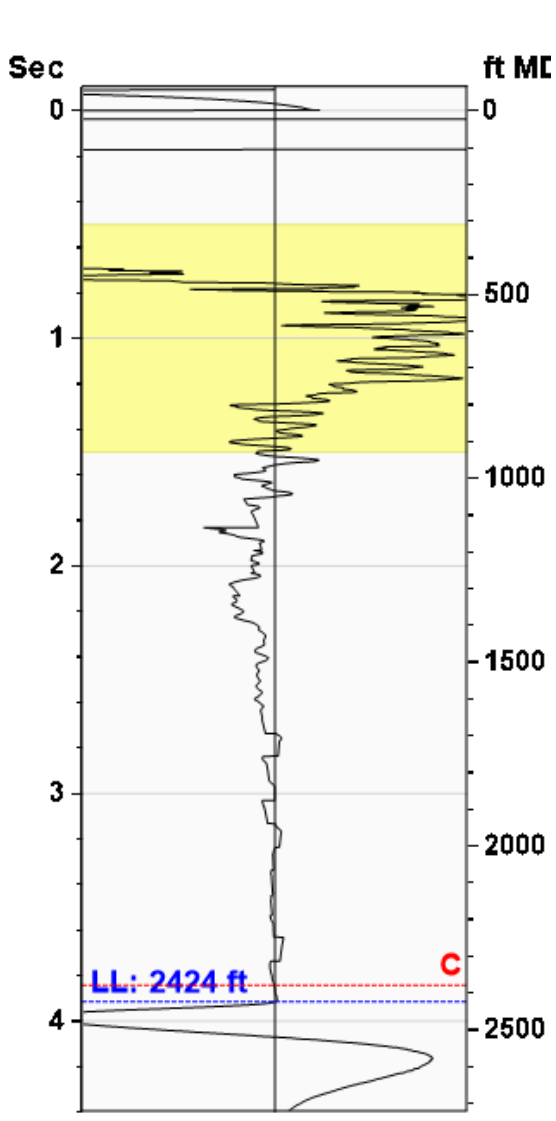

Fluid Above Pump

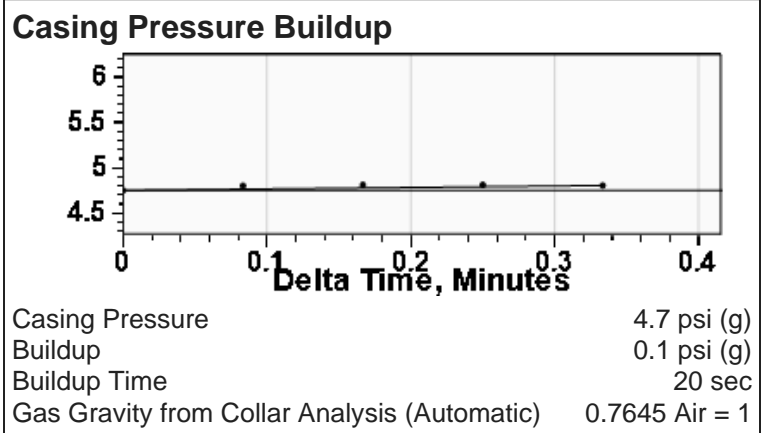
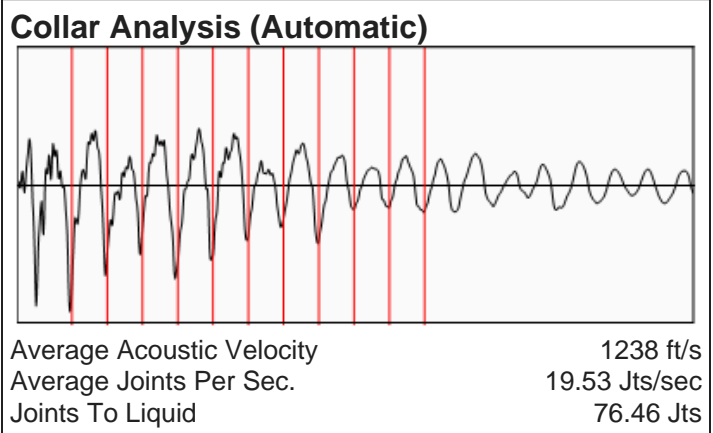
