A. **Title:** THE ASSIGNOR COVENANTS WITH ASSIGNEE, ITS SUCCESSORS AND ASSIGNS, THAT THE ASSIGNOR IS THE LAWFUL OWNER OF AND HAS GOOD TITLE TO THE INTERESTS ABOVE ASSIGNED IN AND TO THE ASSIGNED ASSETS, LEASE, ESTATE, RIGHTS AND PROPERTY, FREE AND CLEAR FROM ALL LIENS, ENCUMBRANCES OR ADVERSE CLAIMS; THAT SAID LEASE IS VALID AND SUBSISTING LEASE ON THE LAND DESCRIBED, AND ALL RENTALS AND ROYALTIES DUE THEREUNDER HAVE BEEN PAID AND ALL CONDITIONS NECESSARY TO KEEP THE SAME IN FULL FORCE HAVE BEEN DULY PERFORMED.
