## ASSIGNMENT OF OIL AND GAS LEASES

For good and valuable consideration, **La Veta Oil & Gas, LLC; La Veta Energy, LLC; Oak Leaf LLC**; and the **Julie Nettare Revocable Trust** (hereinafter collectively referred to as “Assignors”) hereby sell, assign, convey, transfer and set over unto **Dixon Energy, Inc.** (“Assignee”), a Kansas corporation, 1625 N. Waterfront Pkwy., Suite 220, Wichita, KS 67206, and its successors and assigns, all of Assignors’ right, title, and interest in and to the following described property (collectively, the “Assets”), but excluding the Excluded Assets:

- a) the oil and gas leases described on Schedule 1 (each, a “Lease” and collectively, the “Leases”), inclusive of working interests, overriding royalty interests, mineral interests, royalty interests, and any other interest derived from the leasehold estate, together with rights to any acreage pooled or unitized therewith;
- b) the oil and gas wells, and injection or disposal wells described on Schedule 2 (“Wells”), which Wells are situated on the lands covered by the Leases or SWD Agreements;
- c) the equipment, machinery, fixtures and other personal, and mixed property situated on the lands covered by the Leases and SWD Agreements, or otherwise appurtenant to or currently used or held for use in connection with the ownership or operation of the Leases, Wells or SWD Agreements, including, without limitation, well equipment, casing, rods, tubing, pumps, pumping units, motors, tanks, fixtures, machinery, inventory, separators, dehydrators, compressors, treaters, power lines, field processing facilities, surface and downhole equipment, flowlines, gathering lines and systems, transmission lines and all other pipelines (“Equipment”), insofar as it is attributable to the Leases, Wells and SWD Agreements assigned hereunder;

The Equipment is being sold, transferred and assigned from Assignors to Assignee “AS IS”, “WHERE IS”, “WITH ALL FAULTS”, in its present condition, and Assignors hereby DISCLAIM THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument, and all signature pages may be collected into a single counterpart for recording and record-keeping purposes.
