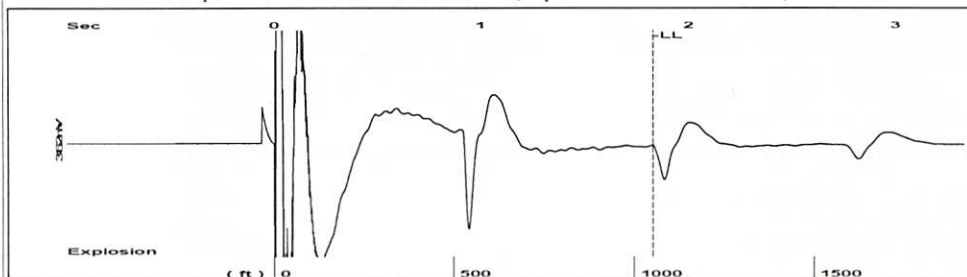

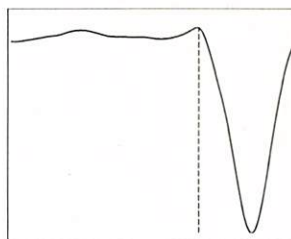

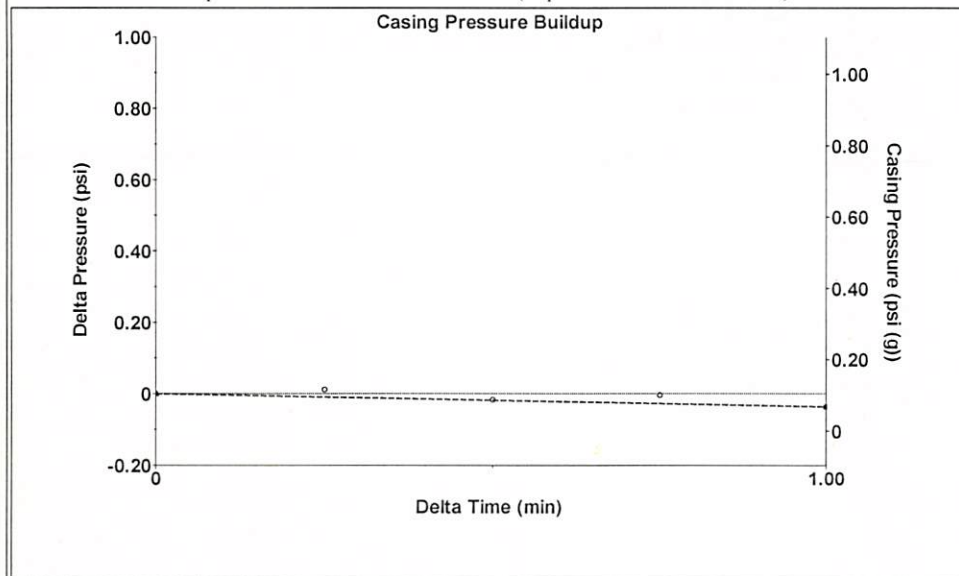

Analysis Method: Acoustic Velocity

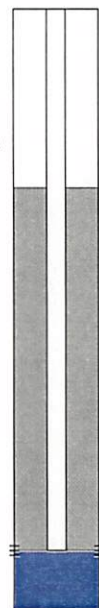
