By signing this Landowner Carbon Benefit Acknowledgment, the undersigned:

- acknowledges that Tradewater Well Services, LLC ("Tradewater") is plugging the Well to generate carbon benefits, and more specifically, carbon offset credits.
- affirms that the undersigned initially granted Tradewater access to the Property to assess the Well on February 10, 2026,
- granted Tradewater ongoing access, with immediate effect, through the completion of the plugging process, and for a period of at least eighteen (18) months thereafter, for the following Well-related activities: leak testing, measurement, plugging and decommissioning, and other post-plugging activities, including plug permanence checks, that may be necessary to generate carbon benefits.
