It is understood and agreed that Assignee shall have inspected the property and premises and satisfied itself as to its physical and environmental condition, both surface and subsurface, and that Assignee shall accept all of the same in its "as is, where is" condition. In addition, Assignors shall make no representation, express or implied, as to the accuracy or completeness of any data, information or materials heretofore or hereafter furnished to Assignee in connection with the Interests, or as to the quality or quantity of hydrocarbon reserves (if any) attributable to the Interests or the ability of the Interests to produce hydrocarbons. Any and all such data, information and other materials furnished by Assignors is provided to Assignee as a convenience and any reliance on or use of the same shall be at Assignee's sole risk.



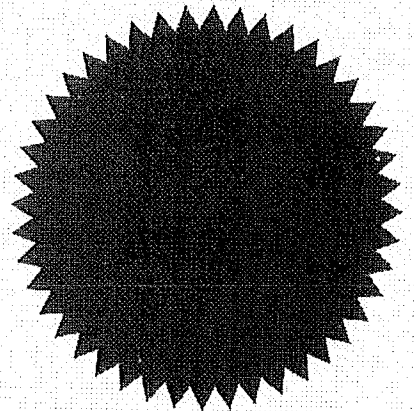
