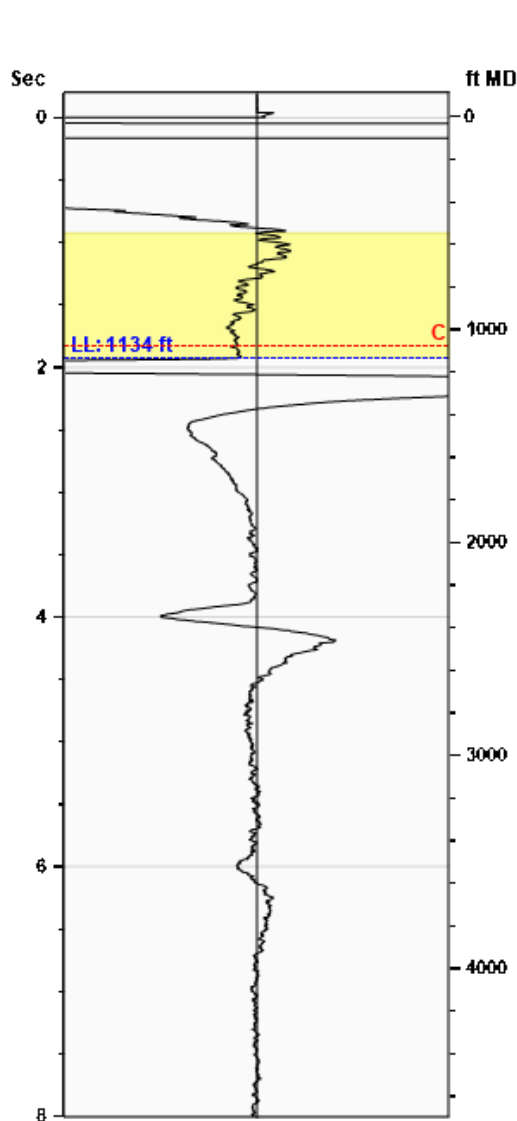

Fluid Above Pump

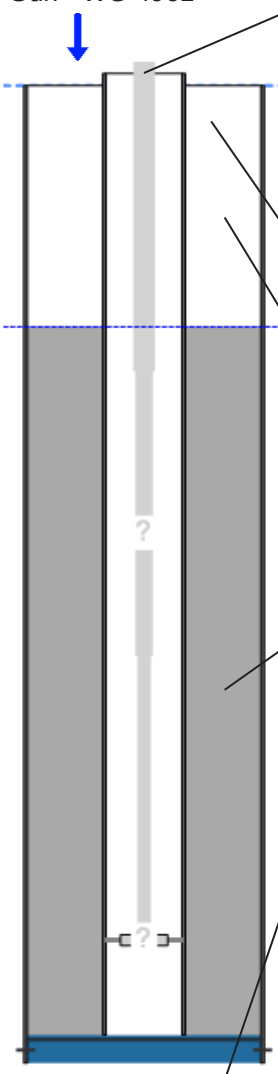

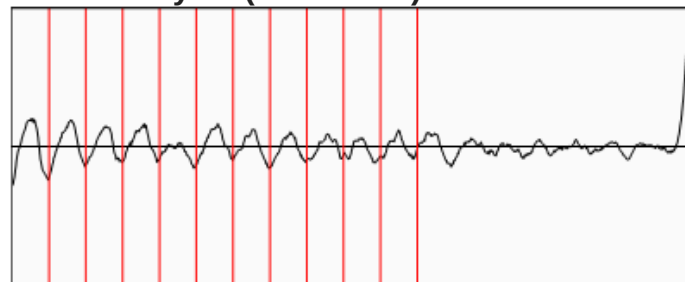

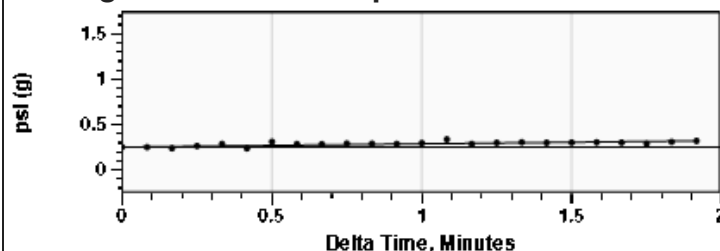
