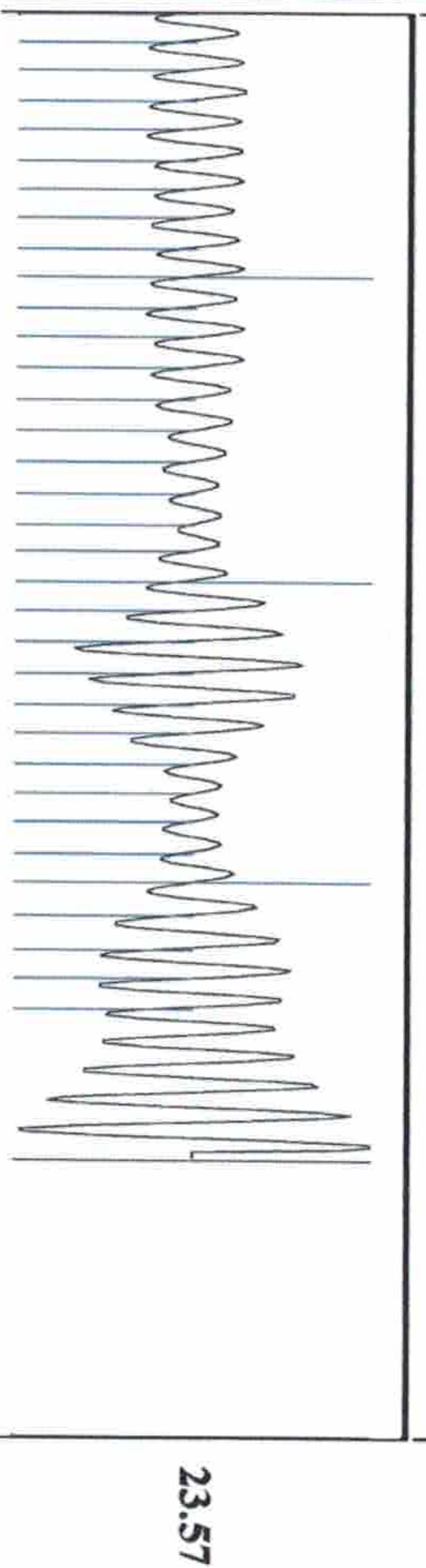
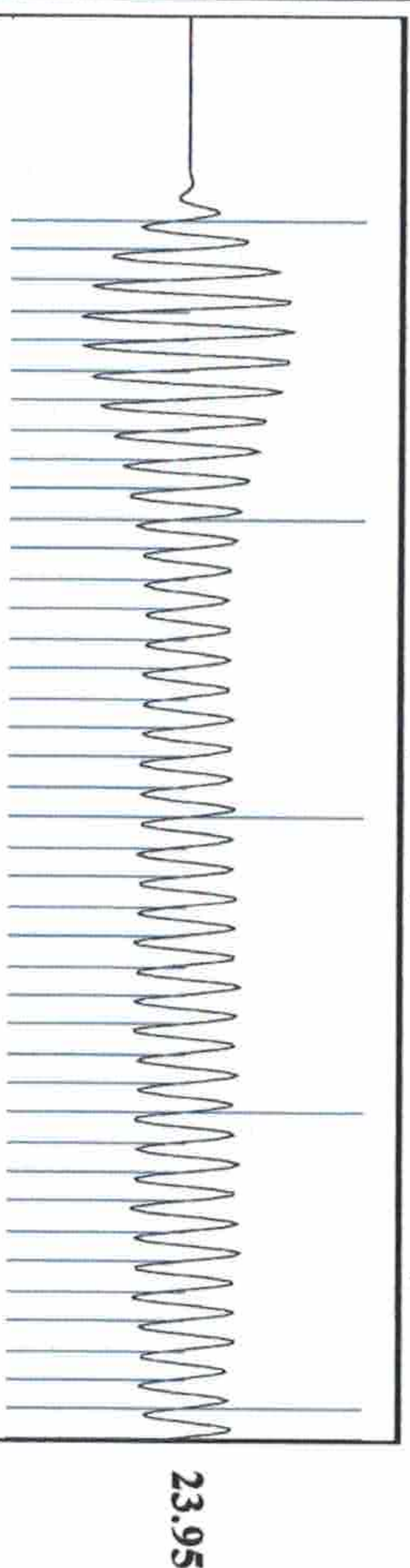


Casing Pressure Buildup
