All property and ad valorem taxes for the above-described property for the year 2025 and all prior years are the responsibility of Assignor. Taxes for the year 2026 shall be prorated up to the Effective Date which will be based on actual 2025 tax amounts.

From and after the Effective Date hereof, Assignee shall assume all liabilities, obligations, and responsibilities with respect to the above-described lease, including, but not limited to, all legal and regulatory obligations and responsibilities with respect to operations, and Assignee shall defend, indemnify and hold Assignor harmless from and against any and all claims, demands, and causes of action of every kind and character, brought by or in favor of any individual, company, corporation, governmental agency or other entity with respect thereto.

This Assignment is subject to the terms and conditions of the lease and is made without warranty of title, either expressed or implied.

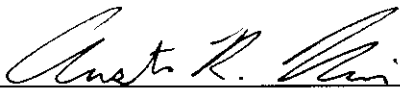

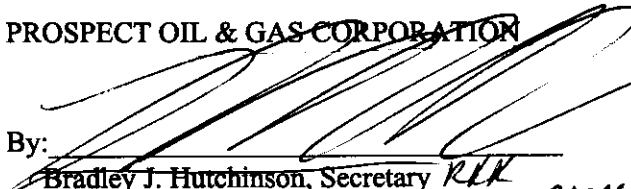

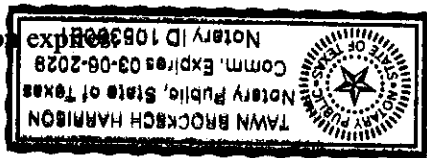
