**Agreement to Transfer Operations**

WHEREAS, Kansas Crude Investments, LLC ("KCI") is the current operator of the following described oil and gas leases, and all of the wells situated thereon, under agreement with Fossil Energy, LLC ("Fossil"), as non-operator working interest owner thereof.

**St. John Lease:** NE/4 26-01S-35W, Rawlins County, Kansas;

**Skolout Lease 2-25:** SE/4 25-01S-35W, Rawlins County, Kansas  
-and the Skolout #2 SWD located in the SE/4 of Sec.23-01S-35W Rawlins County, KS.;

**Johnston G Lease:** NE/4 16-10S-19W, Rooks County, Kansas  
-and the Fehnel #1SWD located in the SW/4 of Sec.16-10S-19W Rooks County, KS.

(hereinafter collectively referred to as "Subject Lease")

WHEREAS, KCI desires to transfer and assign its rights and obligations to operate the Subject Lease and all wells situated thereon ("Wells") under said agreement to Fossil Energy, LLC ("Fossil"), and Fossil desires to take assignment of and assume the obligations associated with operating the Subject Lease and Wells under said agreement.

NOW THEREFORE, in consideration of the premises, and other good and valuable consideration, KCI hereby transfers and assigns all of its rights and obligations under said agreement to Fossil, and Fossil hereby agrees to take assignment of said rights and assume all obligations thereunder, including responsibility for the Wells and the plugging and abandonment thereof. The parties shall cause T-1 Transfer of Operator forms transferring the Wells from KCI to Fossil to be immediately prepared and submitted to the Kansas Corporation Commission.
