KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT is made and entered into this 7th day of July, 2026, by and between Michael Stude, hereinafter called Assignor, and Kirkpatrick Properties, LLC, hereinafter called Assignee.

WHEREAS, Assignor owns the following-described oil and gas wells together with all equipment and other personal property used in connection with the production of oil and gas therefrom, all of which is located in Barton County, Kansas, and described as follows:

fixtures, and all other equipment and personal property used or useable in connection with production of oil or gas from the Bryant Wells.

ASSIGNOR AND ASSIGNEE hereby agree that all sellable oil currently in stock tanks associated with the Bryant Wells shall be the property of Assignee. Assignee further agrees that it will be responsible for ad valorem taxes for the calendar year of 2026 prorated as of the effective date of this assignment.

ASSIGNOR warrants that it has marketable title to all the property assigned herein; that all the property is free of liens, encumbrances, or claims by third parties. Assignor further indemnifies and holds harmless the Assignee from any and all claims, causes of action, and damages related to third party claims of ownership in and to the Bryant Wells and the Assets.

ASSIGNEE hereby agrees that it has inspected the Bryant Wells and Assets assigned and conveyed herein and accept the same as-is and with all faults. Assignee further agrees to indemnify and hold harmless the Assignor from all claims, demands, losses, costs, risks, and expenses incident to or resulting from operations, drilling of additional wells, production of oil or gas, the abandonment and plugging of any well or wells thereon or the removal of any materials therefrom from and after the effective date of this Assignment.

ASSIGNEE shall be responsible for plugging and abandoning the well herein assigned and shall clean and restore the surface at Assignee's expense and in accordance with applicable State and Federal laws, rules, and regulations pertaining to the plugging and abandoning of said well and the restoration of such purpose.

The Assignor and Assignee acknowledges that the previously existing Oil and Gas Lease encompassing the above captioned property, dated May 16, 1984, from Harry B. Bryant, et al, Lessors to Future Energy, LTD, Lessee, recorded in Book 432, Page 334, encompassing the Southeast Quarter (SE/4) of Section Twelve (12), Township Nineteen (19) South, Range Eleven (11) West, Barton County, Kansas, has terminated due to a lack of production and that the Assignors have executed a Release of said Oil and Gas Lease in conjunction with this Wellbore Assignment and Bill of Sale. Parties acknowledge that no working interest in and to the Oil and Gas Lease identified above is being assigned herein as said lease is no longer of any force or effect and the only assets being assigned herein are those set forth above.
