BILL OF SALE AND ASSIGNMENT

BYRD OIL AND GAS LEASE

This **Bill of Sale and Assignment ("Agreement")** is entered into between **Raise Oil, LLC**, represented by its President, **Raisa Zakirova ("Assignor")**, and **Senara Energy, Inc.**, represented by its President, **Artem Kharunov ("Assignee")**.

1. TRANSFER OF ASSETS AND INTERESTS

Effective immediately upon execution of this Agreement by both Parties, Assignor hereby sells, assigns, transfers and conveys to Assignee **all of Raise Oil, LLC's right, title and interest in the Byrd Lease and all associated lease assets and interests**, including wells, wellbores, production equipment, pumping units, tanks, flowlines, fixtures, records, assignable permits, rights-of-way and other property owned by Assignor and associated with the Byrd Lease.

2. CONSIDERATION

The transfer is made **free of charge, for a purchase price of \$0.00**. As consideration for the transfer, Assignee accepts the Transferred Assets and assumes responsibility for ownership and operation of the Byrd Lease from and after the Effective Date.

3. LEGAL DESCRIPTION

The Byrd Lease property is described as:

The Northwest Quarter of the Southwest Quarter and the East Half of the Southwest Quarter, except 10 acres described as follows: Commencing at the Southwest corner of the E/2 SW/4 of Section 32, Township 21 South, Range 11 East; thence North 440 feet; thence East 990 feet; thence South 440 feet; thence West 990 feet to the place of beginning.

4. OPERATION AND RESPONSIBILITY

From and after the Effective Date, **Senara Energy, Inc. shall assume responsibility for operation of the wells and assets within the Byrd Lease boundaries**, including applicable operational, regulatory, environmental, reporting, safety, financial assurance, and plugging and abandonment obligations arising from its ownership and operation.

Assignee shall operate the property in accordance with applicable laws, rules and orders, including the **General Rules and Regulations for the Conservation of Crude Oil and Natural Gas administered by the State Corporation Commission of the State of Kansas (KCC)**.

Except where otherwise required by law, **Raise Oil, LLC remains responsible for liabilities attributable to its ownership or operations prior to the Effective Date, and Senara Energy, Inc. assumes responsibilities attributable to its ownership or operations from and after the Effective Date.**

The Parties agree to cooperate in executing all KCC change-of-operator forms and other documents reasonably necessary to complete the transfer.

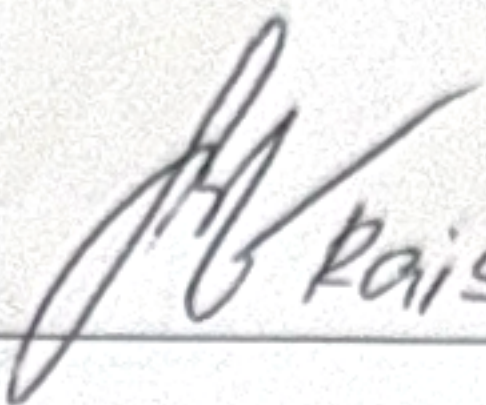
5. ACCEPTANCE
