MEMORANDUM OF ASSIGNMENT OF OPERATIONS

This Memorandum of Assignment of Operations ("Memorandum") is made and entered into August 21, 2026, by and among **Oil Producers Inc., of Kansas ("OPIK")**, license #8061, and **Patterson Energy, LLC ("Patterson")**, license #34888.

WHEREAS, OPIK and Harrison Gilliland are parties to that certain Asset Purchase and Sale Agreement dated July 28, 2026, ("APSA"), pursuant to which OPIK has agreed to transfer operations of the oil, gas, and injection wells described on Exhibit A ("Wells") at the closing of the APSA.

WHEREAS, Harrison Gilliland and Patterson have entered into that certain Purchase and Sale Agreement dated July 21, 2026 ("PSA"), pursuant to which Harrison Gilliland has agreed to transfer operations of the oil, gas, and injection wells described on Exhibit A ("Wells") at the closing of the APSA and PSA to Patterson, and pursuant to which Patterson agrees to accept and assume all of OPIK's obligations for the Wells, which PSA is supported by good and valuable consideration.

NOW, THEREFORE, this Memorandum is made for purposes of memorializing said transfer of operations and to facilitate the transfer of the Wells with the Kansas Corporation Commission.
