For the sum of One Dollar (\$1.00), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers, releases and conveys 100% working interest unto Assignee, its successors and assigns, all of Assignor's right, title, interest, claim or demand in and to the Oil and Gas Leases described on the attached Exhibit "A" and all equipment and other personal property, fixtures and improvements situated upon said Oil and Gas Leases.

This Assignment is made without warranty of title, express or implied. The interests are conveyed herein by Assignor, and Assignee accepts such "as is, where is" and in their present condition with all faults. Assignor has not made, does not hereby make and specifically disclaims, any representations, warranties, promises, covenants, agreements or guaranties of any kind or character whatsoever, whether expressed or implied, at common law, by statute, or otherwise, oral or written, past, present or future as to, concerning or with respect to the interests, including but not limited to (and without limiting the generality of the foregoing), the following: (a) any geological, seismic and other geophysical data; the existence or extent of oil, gas or mineral reserves; the recoverability of or cost or recovering any such reserves; the value of such reserves; any product pricing assumptions; and the ability to sell oil or gas production after closing; (b) the natures, quality or condition of the interests including, without limitation, the water soil or geology of the property subject to the Leases; (c) the existing soil conditions or other conditions of any property subject to the Leases; (d) the income to be derived from any of the interests; (e) the suitability for any and all activities and uses which Assignee may conduct thereon or therewith; (f) the compliance of the interests, or their operation, with any laws, rules, ordinances or regulations or any applicable governmental authority or body; (g) the habitability, suitability, merchantability or fitness for a particular purpose of the
