RE: Explanation for well transfer

To Whom It May Concern:

In November of 2024, S&B Operating assigned several leases in Butler County to Novy Oil and Gas. Those leases were subject to a KCC compliance agreement, of which both Novy and S&B executed. Novy worked on several of the wells among the leases, but was unable to keep up and both S&B's and Novy's license were suspended several months ago. Kansas Resource Exploration and Development has common management with S&B Operating, and while the most recent license renewal went through for KRED it was brought to their attention that S&B's license was suspended due to the compliance agreement not being adhered to (S&B doesn't currently operate any wells in Kansas, so they weren't keeping track of this). Novy has been tasked by the KCC with getting the remaining wells on the compliance agreement in compliance to restore his license and S&B's, and keep KRED's active.

In order to do that, he needs to have the wells under an active operator, so KRED has agreed to take the wells so that they can be worked on by them and other licensed service providers to get back into compliance. Once all wells are in compliance, KRED will transfer the wells back to Novy or to another licensed operator.
