MEMORANDUM OF ASSIGNMENT OF OPERATIONS

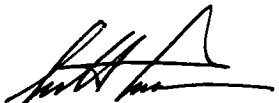
This Memorandum of Assignment of Operations ("Memorandum") is made and entered into August 21, 2026, by and among **Oil Producers Inc., of Kansas ("OPIK")**, license #8061, and **HG Oil Holdings, LLC ("HG")**, license #35871. 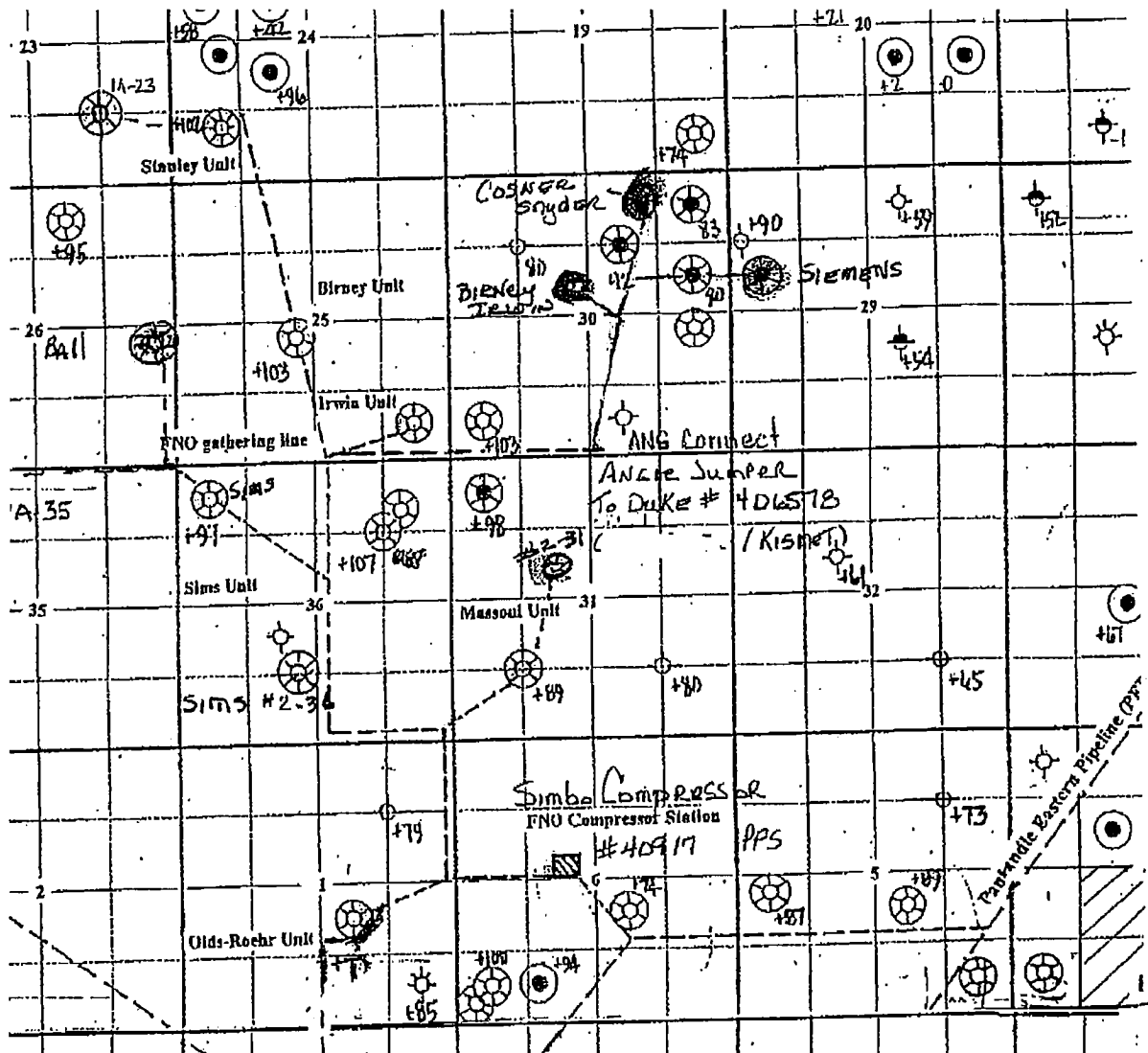

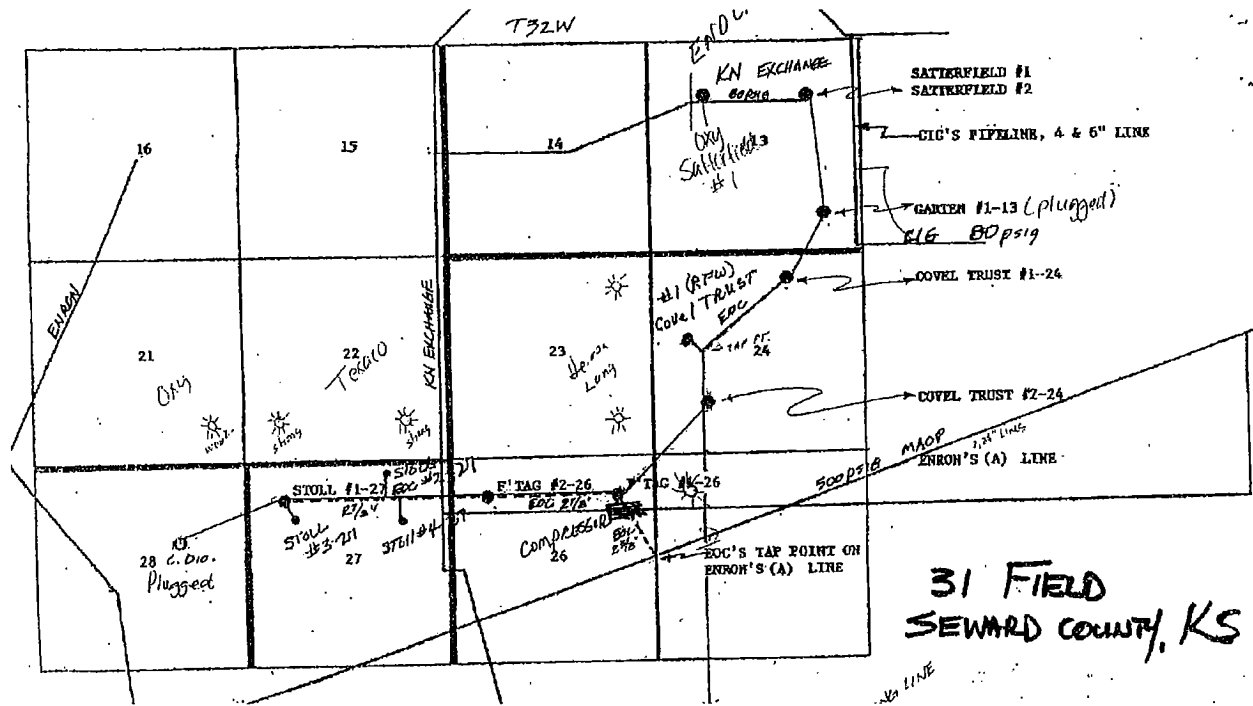

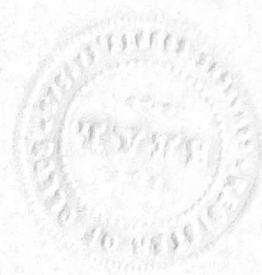

ASSIGNMENT OF OIL AND GAS LEASES

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sell, assign, convey, transfer and set over unto Assignee, all of Assignor's working interest in and to the following described property ("Leasehold Assets"):

a) the oil and gas leases described on Exhibit A (each, a "Lease" and collectively, the "Leases"), together with rights to any acreage pooled or unitized therewith;

b) the oil and/or gas wells, and injection or disposal wells situated on the lands covered by the Leases and Surface Agreements, including those wells described on Exhibit B ("Wells");

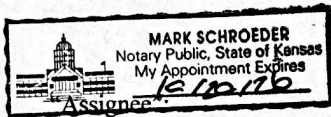
