GLADYS UNIT # 17-1
NW/NE/SE SECTION 30, T28S,R1E
SEDGWICK COUNTY, KANSAS

1. NOTIFY KCC DIST. #2 OFFICE IN WICHITA, KS (316) 651-5506 FIVE DAYS PRIOR TO BEGINNING OPERATIONS.
2. CHECK WELL FOR PRESSURE. FLOW DOWN OR KILL AS NECESSARY.
3. MIRU PU. ND WH. NU CHEVRON CLASS II-B MANUAL BOPE. RELEASE BAKER MODEL AD-1 PKR @ 3046'. POOH, STRAPPING AND STANDING BACK 2-7/8" DUOLINED TBG. L.D. PACKER.
4. MIRU W.L. TRUCK. NU LUBRICATOR. RUN GR/JB FROM $\pm$ 3100' TO SURFACE. RIH WITH CIBP AND SET ON W.L. AT $\pm$ 3100'. POOH. RD W.L. TRUCK.
5. RIH WITH 2-7/8" TBG. OPEN ENDED. TAG CIBP @ $\pm$ 3100'. SPOT 50 SKS. "A" CEMENT ON TOP OF SAME. PULL UP HOLE TO $\pm$ 2600'. CIRC. HOLE FULL OF $\pm$ 9 PPG., 36 VISC. MUD. POOH. L.D. 2-7/8" TBG.
6. RU W.L. TRUCK. NU LUBRICATOR. RIH AND PERFORATE 5-1/2" CASING AT $\pm$ 350'. POOH WITH CASING GUN. RDMO W.L. TRUCK.
7. TIE ONTO 5-1/2" CASING. OPEN 8-5/8" X 5-1/2" ANNULUS. EST. CIRC. DOWN 5-1/2" CASING, OUT PERFS. AT $\pm$ 350' TO SURFACE OUT 8-5/8" X 5-1/2" ANNULUS. MIX AND PUMP SUFFICIENT "A" CEMENT DOWN 5-1/2" CASING TO CIRCULATE CEMENT TO SURFACE OUT 8-5/8" X 5-1/2" ANNULUS. WHEN CEMENT CIRC. TO SURFACE, CLOSE ANNULUS AND SQUEEZE $\pm$ 50 SKS. INTO SAME. IF WELL WILL NOT CIRC., PUMP $\pm$ 200 SKS. DOWN 5-1/2" CASING AND $\pm$ 100 SKS. INTO 8-5/8" X 5-1/2" ANNULUS. LEAVE 5-1/2" CASING FULL OF CEMENT.
8. ND BOPE. CUT OFF CASINGS 6' BELOW GL. TOP OFF WITH CEMENT AS NECESSARY. WELD ON CAP AND I.D. WELL. RDMO PU. CLEAN UP LOCATION. TURN WELL OVER TO PRODUCTION TO RESTORE LOCATION.

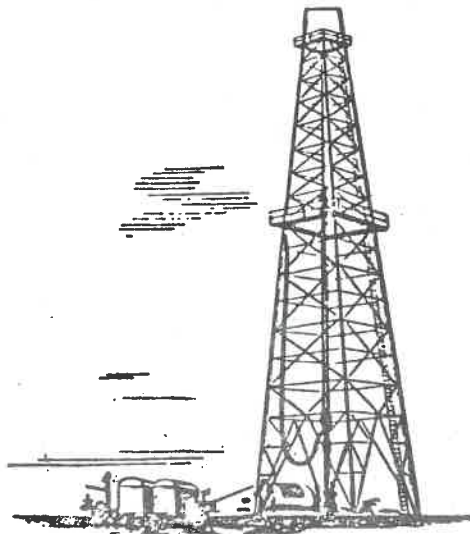
