PROCEDURE

1. NOTIFY KANSAS CORPORATION COMMISSION PRIOR TO COMMENCEMENT OF PLUGGING OPERATIONS. FILE PLUGGING APPLICATION FORM (CP-1) PRIOR TO START OF PROCEDURES. (620) 225-8888 (DODGE CITY OFFICE)
2. MIRU WELL SERVICE UNIT. LAY DOWN & WAREHOUSE RODS & PUMP.
3. RELEASE TUBING ANCHOR, TOOH AND LAY DOWN 160 JTS. 2 3/8" TUBING, PERFORATED SUB, AND MUD ANCHOR. TRUCK TO STORAGE LOCATION OR SELL ON-SITE.
4. RD & RELEASE WELL SERVICE UNIT.
5. MOVE IN CEMENTERS, RU TO CASING, ESTABLISH PUMP RATE, PUMP 40 SKS CEMENT FOLLOWED BY 200# HULLS, GEL SPACER TO 3261', THEN CEMENT VOLUME TO COVER CASING FROM DV TOOL TO SURFACE (3261' - SURFACE).
6. DIG OUT SURFACE CASING AND CASING HEAD, PUMP 50 SKS. FOR SURFACE CAP IF NEEDED.
7. CUT OFF CASING AND WELLHEAD 4' BELOW GROUND LEVEL.
8. REMOVE SURFACE EQUIPMENT AND RESTORE LOCATION.
