The undersigned hereby affirms that the drilling, completion and eventual plugging of this well will comply with K.S.A. 65-101 et. **RECEIVED**  
 It is agreed that the following minimum requirements will be met:

1. Notify the appropriate district office *prior* to spudding of well;
2. A copy of the approved notice of intent to drill *shall be* posted on each drilling rig;
3. The minimum amount of surface pipe as specified below *shall be set* by circulating cement to the top; in all cases surface pipe *shall be set* through all unconsolidated materials plus a minimum of 20 feet into the underlying formation;
4. If the well is dry hole, an agreement between the operator and the district office on plug length and placement is necessary; **WICHITA, KS**
5. The appropriate district office will be notified before well is either plugged or production casing is cemented in;
6. If on ALTERNATE # COMPLETION, production pipe shall be cemented from below any usable water to surface within 120 days of spud date. *In all cases, NOTIFY district office* prior to any cementing.

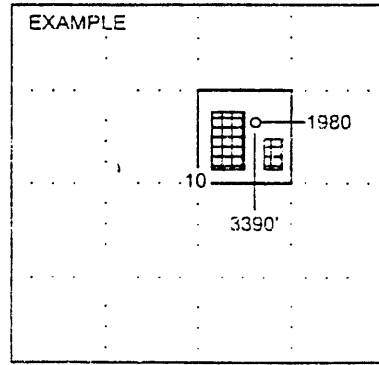
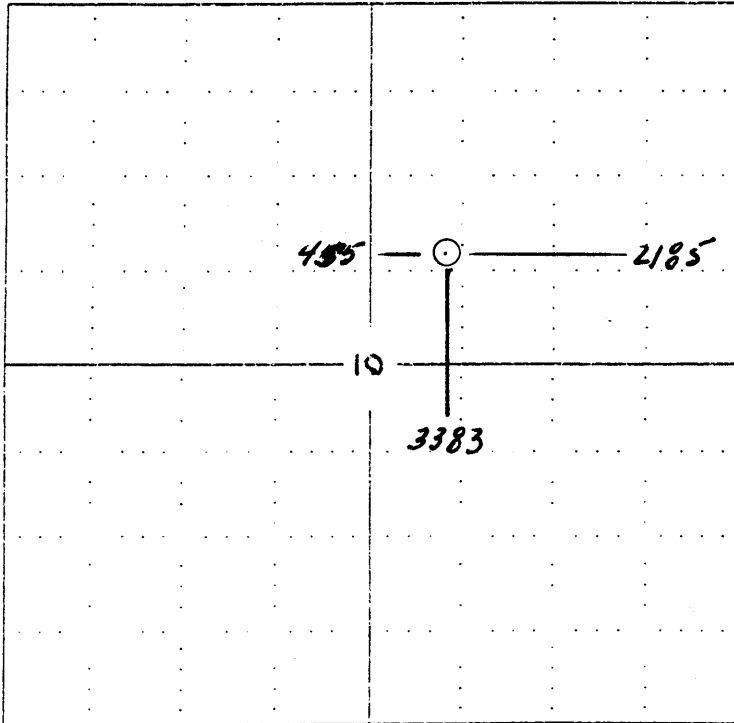
