Dear Sir:

Please pardon my delay in answering your letter of March 10, which arrived at the busiest part of our income tax season.

I have made a search of my files and failed to find a log for any of the three wells located on the A. C. Maxwell-Jackson Lease in the SW/4 of Section 33, Township 1 South, Range 18 West, Phillips County, Kansas.

Our number 1 well was drilled by Honaker Drilling Company of Great Bend, Kansas. The number 2 and 3 wells were drilled by the A & M Drilling Company of New Castle, Wyoming. Mr. A. C. Maxwell of the A & M Drilling Company acted as operator for the property until January 31, 1951, and was the representative for all of the owners of the working interests at the time the three wells were drilled. On February 1, 1951, he and his associate in the A & M Drilling Company sold their interest to the Honaker Drilling Company, which company then became the operator and continued until the lease was sold in December 1952.

I believe you can secure the logs for these wells by writing to either Honaker Drilling Company, 2008 Lakin Avenue, Great Bend, Kansas, or A. C. Maxwell, Post Office Box 327, New Castle, Wyoming.
