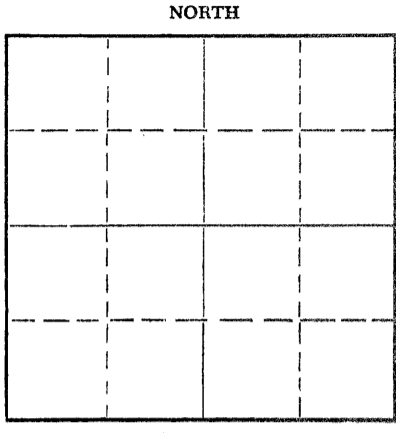

Pulled 7 jts. Circulated hole with 31 sacks gel and spotted 20 sacks cement at 500'. Pulled 10 jts. and spotted 20 sacks cement at 160'. Pulled 5 jts. Total 85 jts.  
Mudded hole back to 35' and sat 5' rock bridge. Mixed and dumped 10 sacks cement to base of cellar.
