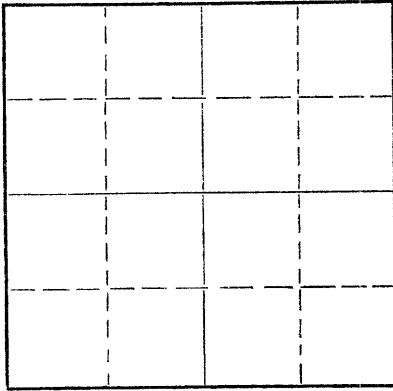

Plugged off bottom with sand to 3720' and dumped 4 sacks cement with bailer. Shot 5 $\frac{1}{2}$ " casing at 1,530'. Perforated and spotted oil. Worked and shot pipe. Bailed hole down to 215', and set permanent rock bridge. Put 25 sacks cement on bridge and capped off top with 10 sacks. Well completed.
