Commission records indicate that the above referenced well was last owned and/or operated under your name and that the well appears to have been abandoned and unplugged longer than ninety (90) days. Furthermore, there is no record at the Conservation Division Office that current Temporary Abandoned status has been requested or granted.

K.A.R 82-3-111 states in part:

(a) **Within 90 days after operations cease on any well drilled for the purpose of exploration, discovery, service or production of oil, gas or other minerals, the owner or operator of the well shall:**

- (1) Plug the well; or
- (2) File an application with the Conservation Division requesting Temporary Abandonment, on the forms prescribed and furnished by the Conservation Division.

This letter is to serve notice that the above referenced well is in violation of K.A.R. 82-3-111. **Said well must be placed back into production, plugged or classified as a Temporary Abandoned well, provided approval is granted**, by filing a CP-111 Form with the Kansas Corporation Commission, Conservation Division: Attention Richard Williams, 2301 East 13th Street, Hays, Kansas 67601.

This needs to be accomplished by **September 03, 2004**. Failure to comply with this request may result in the imposition of administrative penalties as well as an order to plug the subject well. Your prompt attention will be appreciated.



If a workover pit will be used during the plugging of the well it must be permitted. A CDP-1 form must be filed and approved prior to the use of the pit.

The Conservation Division's review of form CP-1, either in the central or district office, does not include an inquiry into well ownership or the filing operator's legal right to plug the well.

This notice in no way constitutes authorization to plug the above-captioned well by persons not having legal rights of ownership or interest in the well. This notice is void after ninety (90) days from the above date.
