Ran & washed 1 1/4" pipe down hole to 370', hooked cement pump to 1 1/4" pipe, gelled hole, pumped 50' Portland cement,  
plug on bottom, then pulled pipe up to 250' and pumped from 250' to surface, pulled pipe out of hole  
topped off well, used 82 sx. Portland Cement. Emptied pit, transferred contents from pit to disposal well,  
cut off surface pipe below ground level, and cover over pit and well site with backhoe.

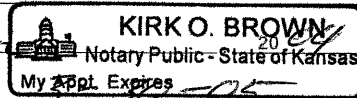
