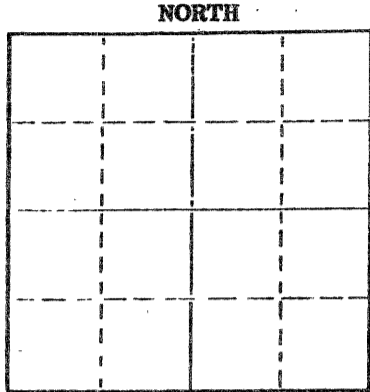

Pump 15 sacks gel - 3 sacks hulls - 70 sacks cement - 15 sacks gel plug 50 sacks cement.

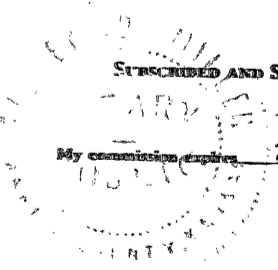
