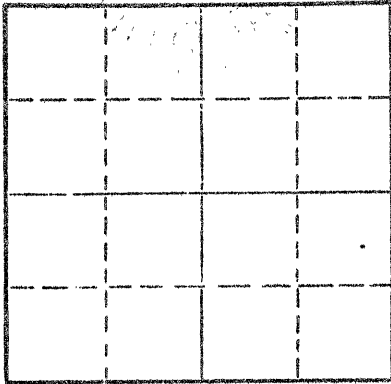

Made bottom hole plug back with sand to 3630'. Mixed and ran 4 sacks cement thru dump bailer. Pushed plug 3350'. Sanded back to 3340'. Mixed and ran 3 sacks cement thru dump bailer.
Squeezed hole with 5 sacks hulls and 20 sacks gel. 70 sacks cement and 15 sacks gel. Released plug and displaced with 50 sacks cement.

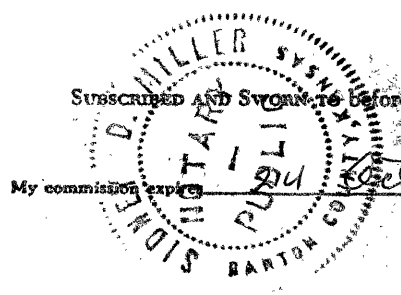
