Hooked to 5 1/2" casing & pumped 15 sx to 500# & SI. Witnessed by Rich Williams, KCC.

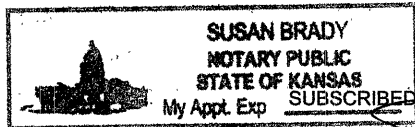
