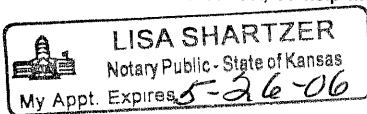
Plugged well using the squeeze method. A total of 28 sacks of Portland cement were used to plug this well. Shut in pressure was 750 psi.
