8 5/8' SP @ 270' w/185 sxs. 5 1/2" csg @3761' w/175 sxs. Perforated and squeezed @ 612' w/125 sxs, 769' and 1410' w/350 sxs.

Plugging procedure; squeezed 200 sxs cement and 400 lbs hulls down 5 1/2" casing to 650 # maximum, 400# shut-in.

Annulus was pressured to 500#, would not take cement. Plug down. Cement type, 60/40 poz mix with 10% gel.
