Well developed a casing leak at or near 370' and we spent 3 days reaching that depth pulling out 370' of 3 1/2" OD Durolined tubing. Then spent 2 days without going any further. Ran 2 1/2" OD tubing to 370' and circulated 150 sacks cement in casing and also circulated to top of surface pipe. Pulled tubing and refilled 5 1/2" with 4 sacks. Checked surface pipe and it was full. Job completed at 1pm. Greg Ives of KCC witnessed job.
