OF THE CEMENT TO BE PUMPED. CEMENT WAS PUMPED INTO THE 2 7/8" CASING UNTIL THE WELL WOULD
HOLD PRESSURE. THE WELL WAS THEN SHUT IN AT 600PSI: 28 SACKS OF CEMENT WERE PUMPED INTO THIS WELL.

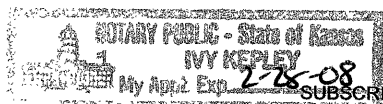
