THE PUMP TRUCK WAS CONNECTED DIRECTLY TO THE 2 7/8" CASING. COTTON SEED HULLS WERE MIXED WITH THE FIRST OF THE CEMENT TO BE PUMPED. CEMENT WAS PUMPED INTO THE 2 7/8" CASING UNTIL THE WELL WOULD HOLD PRESSURE. THE WELL WAS THEN SHUT IN AT 350 PSI: 25 SACKS OF CEMENT WERE PUMPED INTO THIS WELL.
