Plugged well with 60/40 pozmix, 10% gel as follows: Pumped 10 sacks down the outside of 5-1/2", then pumped down inside of 5-1/2" -- 50 sacks cement with 600# hulls, then 22 sacks gel spacer, and 145 sacks cement, all on 8-10-06. Finished on 8-23-06 by pumping 25 sacks through 1" pipe to fill to surface.

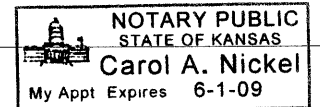
