Pulled tubing from well and tied on to 4 1/2" casing. Pumped 75 sacks of same cement and cement circulated out of annular space. Job complete.

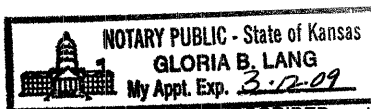
