Casing stays full. Allied ticket # 32990 RDMO. All cement was 60/40 poz Mix 10% gel.

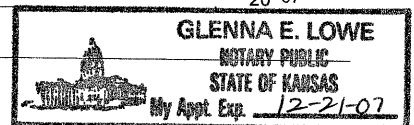
