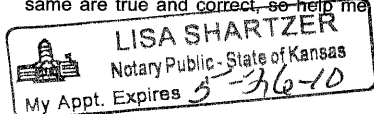
Plugged well by using the squeeze method. A total of 92 sacks of Portland cement were used to plug this well.
