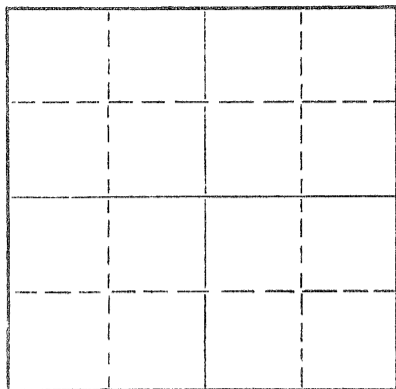

Checked hole, sanded hole to 3400' and dumped 3 sacks of cement @ 3400' with dump bailer. Pulled 70 jts. of 4 1/2" casing, pumped in 28 sacks of gel mud and 20 sacks of cement. Pulled 4 1/2" casing to 250' and pumped 20 sacks of cement. Pulled balance of 4 1/2" casing and capped hole with 10 sacks of cement.
