Two inch casing rotted off down hole 220 feet. Installed rag packer inside bore hole at 210 feet. Squeezed cement through casing until pressured up. Pulled rag packer out and topped well off. A total of 117 sacks of Portland cement were used to plug this well. Casing was cut off below plow depth and location restored.
