Tubing stuck, backed off tubing, came out with 62'. Left 590' of 2-3/8" tubing in the hole. Plugging Complete. Used 60/40 pos, 6% gel.

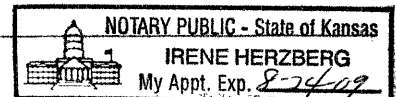
