Filled casing from bottom to top with cement. Pulled 1 inch out and topped off well.

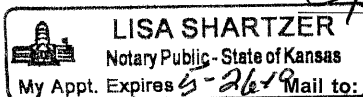
A total of 169 sacks of Portland cement were used to plug this well. Casing was cut off and location restored.
