The pump truck was connected directly to the 2 7/8" casing. Cotton seed hulls were mixed with the first of the cement to be plugged. Cement was pumped into the 2 7/8" casing until the well would hold pressure. The well was shut in at 750 psi. 35 sacks of cement were pumped into this well.

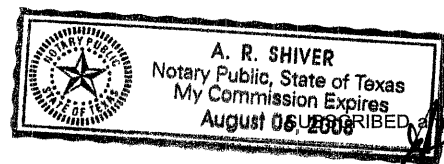
