Connected back to 5 1/2" csg. & pumped 175 sx. 60/40 Pozmix w/6% gel, & 4 sx. hulls. ISIP - vac. Filled 5 1/2" to surface w/Redi-mix. Calc. volume pumped dwn 5 1/2" = 5305'. Calc. volume pumped dwn 5 1/2" & 8 5/8" annulus = 199'. (If additional description is necessary, use BACK of this form.)
