3899'--5 1/2" Production casing cemented on bottom with 125 Sx. 5 1/2" has  
been squeezed @ 2062' with 425 Sx. cement. Well plugged back to 3875'  
Top perforations @ 3831'.

Push plug to 3800', sand back to 3775' and set 5 Sx. cement with dump  
bailer. Pull 5 1/2" casing and squeeze well with 5 sacks hulls, 30 sacks  
gel and 150 Sx. cement, staged.
