Prior to job set 21' of 8 5/8" surface, cemented in hole with 6 sacks of Portland cement. Washed 650' of 1 1/4" casing down hole, established circulation with 10 bls. of water, hooked onto 1 1/4" then pumped 60 sx. cement, pulled 300' of 1 1/4" pipe & pumped 90 sx. cement, pulled 350' of 1 1/4" pipe and topped off well. Used total of 150 sacks of OWC with 4%Gel.

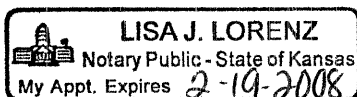
