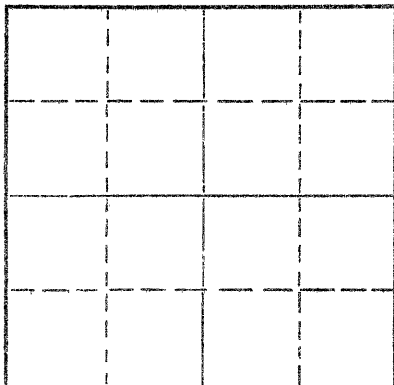

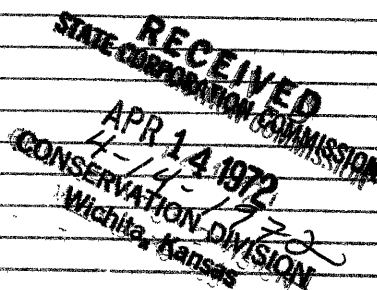

Dumped 250 gals sand down 4 1/2" casing and flushed with 1 load of water
Dumped 60 gals sand down 4 1/2" casing and flushed with 1 load of water. Checked sand and found top of sand at 3090'. Mixed and ran 4 sacks cement thru dump bailer.
Squeezed hole with 3 sacks hulls, 20 sacks gel, 2 sacks hulls - 70 sacks cement and 8 sacks gel. Released plug and displaced with 50 sacks cement.
