Pulled rods and tubing for plugging. Run tubing back to 2500'. Swift pumped 240 sx 60/40 Pozmix w/4% gel and 1 sx CC and 8 sx hulls. Pulled tubing up to 1500' and pumped 75 sx 60/40 Pozmix w/4% gel and 1 sx CC and 8 sx hulls. Cement circulated to surface. Pulled rest of tubing and hooked to surface pipe. Pumped 35 sx 60/40 Pozmix down surface and pressured to 200 psi. Topped off 5 1/2" casing w/40 sx cement. KCC rep Darrel Dipman on location during plugging.
